The meeting was called to order at 7:31 pm by President Dick Thompson. Officers in attendance were Dick Thompson, President; Tom Mansfield, 1st V.P.; Dick Fritz, secretary; and Tom Kay, treasurer. 31 member clubs were represented along with one associate member and two individual members. Rick Beets of the CORSA Corvair Club of Colorado and Sara Bain from Hagerty Insurance were welcomed as guests.

Legislative: Leo Boyle was unable to attend.

Nominations for 2019 CCCC officers and election there of: The floor was opened for additional nominations, followed by *complete silence*. Since the current officers have agreed to continue in their present offices, it was moved and seconded that nominations be closed and the current officers be reelected. The motion passed by majority vote with one objection but the First Vice President was overruled.

Meeting with Colorado Department of Revenue officials: John Mack summarized the meeting he, Dick Thompson and Leo Boyle had with Kyle Boyd and Adam Wilms of the DoR to clarify guidelines issued to county clerk and recorders regarding registration of vehicles with collector series license plates. The Department is using a new computer system known as CSTARS which may have misled county offices. As reported in an attachment to the October CCCC meeting minutes, there are three categories of vehicles eligible for collector series registration:

- Vehicles built 1975 and earlier:
- Vehicles built 1976 and later that were registered as collector items before September 2009;
- Vehicles at least 32 years of age.

In addition, CSTARS will soon include dual-registration for vehicles with **Year-Of-Manufacture plates**. In any event, it is imperative that owners with YOM plates carry the regular plates as well as certification of the YOM registration with the state.

2019 Air & Ground Show, CCCC Swap Meet and Car Show: Dick Thompson met with Rocky Mountain Metro Airport (RMMA) officials to confirm plans for an air and ground show, to include the CCCC swap meet and car show in 2019. The RMMA officials noted that there are three classes of air shows;

- Class 1: Full professional air shows that may include military teams such as the Navy's Blue Angels or Air Force Thunderbirds;
- Class 2: Hired aerial aerobatic performers such as those putting on demonstrations at the 2018 event;
- Class 3: Performances with arranged fly-bys and fly-ins.

We and RMMA intend to have the 2019 show be of the third category, and RMMA is negotiating for a Class 1 show in 2020. For CCCC, the 2019 swap meet and car show will be in the same area as 2018 and with enhanced parking and shuttle services for spectators and buyers. Note the date of **August 3, 2019** in club calendars

CCCC often receives requests for special cars for weddings. Rich Somers used to handle these but it is not known if he does this or if someone makes a business of providing such vehicles. There were anecdotal stories of the risks of abuse of vehicles so owners are cautioned.



OFFICER REPORTS

Liz- N/A

Kitty- advised we have 114-116 members. Steve Hart and Jeff Rose renewals are pending. Four members have been removed. Letters have gone out. Action Awards advised that due to a change in state laws that rates will be charged on anything being shipped. Locality taxes will now be applicable.

Dave B – has one order for Regalia that needs to be given to Eric Malewska.

David D - Regalia page has not been in newsletter for the last few months because of the abundance of content. It is available on the website.

Brad--Did not have anything for October. He did have one question as to why the month financial report was not in the last newsletter, although nobody complained.

Andrew – Thanked Deb and Mark Bosler for the wine tasting event they hosted. Christmas party is our next event. He is hoping that Brooks Turner and Nancy will host another Chili Cook-off next year.

Christmas Party was discussed. There was a meeting at the Bosler's with Judy and Bob Becwar, Kitty and Andrew Janiesch, Deb and Mark Bosler and Mike and Barb McGuire. The party will have the entrée catered by Lil' Riccis costing \$10.00 per person. Deb said she would do a Maggiano's type salad for the event. Certificates would be given out to those members who hosted an event. Handoff would be done at the January Board meeting to the new officers. Andrew indicated he would need the raffle tickets from Dave B. Desserts would more than likely be from Costco (cheesecake, tuxedo cake, assorted cookies) and would cost \$75.00 or less. NEW BUSINESS

VTR 2020 – Request from events coordinator to do VTR in 2020—only a year and a half away! California Triumph clubs put on "Triumph Fest" every year until now. They will now be doing every other year so 2020 will be the first year without Triumph Fest. The event normally pulls 300-400 cars. They figured possibly 75-100 of those vehicles would come to Colorado. 2021 would be a Triumph Fest year plus 10th year for VTR for our club. Terry responded back that we would discuss at our Board Meeting and General Meeting and get back to him as soon as possible. The invite was not sent out to other clubs. Our club did have issues in 2001 and 2011 with the hotel, event site, auto-cross permissions would need to be obtained. Breckenridge and Colorado Springs were brought up as possible sites. We also discussed the future, possibly doing VTR in 2021 or 2022. Deb Bosler brought up that Ann Robins from Driving with Kids and the Lotus club said she has contacts in Colorado Springs as a possibility.

Liz Reed moved to not host 2020 VTR and that an exploratory committee be formed to check out the possibility of the club hosting a future VTR. Dave Bosh seconded the motion. Most importantly, a venue and enough people are paramount at this point in time.

VTR national has criteria and guidelines that need to be followed. They supply the awards. The question remains will we have enough support from the club?
