

Burger Hunt Report, by Andrej Galins



It was 2015, my daughter and I were working on the Six one winter weekend. I believe we were upgrading the suspension with Nylatron bushings and a package from GoodParts. She turned to me and asked, "What will you do when the Six is done?" A fair question, and truth be told, I am not sure I will ever be done with the Six, but I turn to her and say, "What would you like to do?" A smile forms on her face and she says, "We should go get hamburgers at every hamburger place in Colorado."

After some thought, I began to develop a way to include other members of the club. A few more weekends working on the Six and talking it over with my daughter, the RMTC's Burger Hunt was born. Simple premise, find good burger places, drive our Triumphs to each venue, eat their burgers, score their burgers and award the overall winner with a plaque from the Rocky Mountain Triumph Club.

We did not go to 'every hamburger place in Colorado', but with the help of the Denver Burger Club, I narrowed down to about 12 that looked like a good place to grab a burger. We hit a place once a month during the driving season of 2018. I took price into consideration, some places had a \$20+ burger and I felt that was a tad high if we were to do that five or six times, so we did not visit those places, but if you like please let me know how Humboldt at 1700 Humboldt Street does their \$20+ burger.

Here is our list of the places we visited...

I had about 6-8 RMTC members that came and tried burgers at every place. My 'partners in burgers' Michelle my wife and Kaija my daughter, Patrick Huckles and his wife Viv, Debbie and Mark Bossler, David and Arlene Bosh, Kitty and Andrew

Janiesch, Dave Durstine and on occasion Ralph Malewska. We drove from Denver to Colorado Springs in our hunt for the best burger. I decided that 'big chain' burger joints were off our list. Once the burger hunt team knew the location via an email, we met at said location. I provided score sheets that captured everything from burger appearance, taste, extras, to dollar value. The best overall score was out of 90 points. Our RMTC burger judges also made notes if they felt they wanted me to know something more than the score reflected.

And now to our 2018 RMTC'S burger hunt winner... Now if this was just based on price-point, Bud's Bar would be our winner at a good burger with no frills for less than 5 bucks.

But that was not the formula we used. Our criteria was based on 9 rated categories; execution, appearance, taste, bun, toppings, fries, quality of service, dollar value and was the burger made to specifications. Again, judges scored all categories best out of ten.

And now to our 2018 RMTC'S burger hunt winner...with an average score of 84, our burger hunt best burger went to Park Burger. Each judge ordered a burger they wanted such as the popular 'Get Figgy Wit It' to the house 'Park Burger'. Please look for an email announcement with a date and time as we will present Park Burger with our plaque. We invite you to join us for a great burger as we enjoy the fruits of our labor.

Just behind Park Burger was Highland Tap and Burger with an average judge score of 80. And finishing out our 'top 3 burger joints' was TAG Burger with an average judge score of 75.

Minutes of Meeting, 5 December 2018

The meeting was held at the Forney Museum of Transportation, 4303 Brighton Blvd., Denver Colorado The meeting was called to order at 7:31 pm (for the fourth month in a row) by President Dick Thompson. Officers in attendance were Dick Thompson, President; Tom Mansfield, 1st V.P.; Samantha Baker, 2nd V.P.; Dick Fritz, secretary; and Tom Kay, treasurer. 34 member clubs signed in along with two individual members.

Legislative: Leo Boyle noted that the recent election of Colorado's legislators and ballot initiatives will bring about definite changes in the legislative landscape. Although the drilling set-back was defeated he expects that there will be legislation to revisit the issue. He also expects that there will be bills dealing with air quality. Statehouse committee assignments are not yet completed but the new chairperson of the senate transportation committee, Faith Winters, and the lieutenant governor, Diane Primavera, are persons we have worked with in the past. The 2019 legislative session will begin on January 4th and end on May 3rd.

2019 Budgets: The individual budgets (Operating Account, Government Relations Account, Swap Meet and Car Show Account, and Cruise Account) were each presented and discussed. The recurring deficit in the Government Relations Account (to pay for our lobbyist) was noted, and ideas to reduce it were discussed. Approval of each of the budgets was moved, seconded, and adopted. The dues and assessment structures were discussed and will remain the same in 2019 as they were in 2018.

Presidents' Night: Our annual Club Presidents Night will be on **February 6** and will focus on encouraging young people to join the car collecting hobby. Location will be at the Lincoln College of Technology, 11194 E. 45th Ave., Denver. We hope that tours of the Center can be arranged. More details next month.

SEMA: SEMA has noted that the US Congress passed legislation in 2015 to allow small volume automobile manufacturers to build turn-key replica cars (as distinct from engine-less kit cars) in the US. The Department of Transportation was directed to implement the law no later than December 2016 but has not done so, thereby stifling an emerging industry. SEMA is urging car collectors to put pressure (by contacting senators and representatives) on DOT to some up with regulations.

The Latest Scoop (TLS) and Old Cars Weekly News & Marketplace (OCW): These two subscription publications offer an opportunity to promote club events in the Rocky Mountain states (TLS) and national (OCW) scenes. OCW in particular virtually omits Colorado events in its calendars because no one submits information. Addresses are provided as an addendum to these minutes.

Forney Museum Support: Dust n'Shine events can assist the museum and provide an interesting club event, likewise club tours which can include guided information about the facility.

In 2017, Hemmings Sports & Exotic Car halted publication with the May issue. After a 12-year run, it was a difficult — but necessary — decision to make, and we continue to receive reader feedback on the beloved magazine's closure. With that in mind, we have a bit of good news to report:

Beginning with the March 2019 issue of Hemmings Classic Car, we'll incorporate a limited amount of foreign and import car coverage within its pages, at least on a trial basis.

As editor Richard Lentinello explains in his February 2019 Hemmings Classic Car column, we're not taking anything away from the magazine readers know and love. The page count dedicated to American classics will remain the same, which means we'll be adding pages to include coverage of automobiles from marques like Alfa Romeo, Austin, BMW, Bugatti, Citroen, Datsun, Ferrari, Jaguar, Rolls-Royce, and others. For many of us in the hobby, our passion extends beyond a single manufacturer and beyond a single country, which is why we believe expanding coverage within Hemmings Classic Car is the right thing to do.

While this is an experiment, we believe it will prove to be a successful one, broadening the appeal of Hemmings Classic Car and working towards Richard's goal of creating the best publication in the collector-car hobby today. The Passing of Mike Cook, submitted by Gordon Kenney

Michael L. "Mike" Cook passed away on Tuesday, November 27, after a short illness; he was 85. Mike was editor of Jaguar Journal for many years and author of numerous books on both Jaguars and Triumphs.

Born in Winnepeg, Manitoba, Canada, in 1933, Mike moved with his family to Glendale, Ohio, in the 1940s. Like many young people of that era, he became a hardcore sports car enthusiast, and, in 1957, purchased a 1955 Triumph TR2 that he drove to SCCA races at air bases in Columbus and Akron. Mike soon joined the <u>Triumph Sports Owners Association</u>— a

corporate-backed enthusiast group publishing a newsletter that provided information to owners looking to prep their cars for competition, among other topics — and made contact with the Standard-Triumph Motor Company Inc. in New York City, where he would be hired in August 1958 as STMCI's assistant advertising manager and executive secretary of the TSOA.

Employed there as Standard-Triumph became part of the Leyland Motor Corporation in 1961, Mike would continue through the business changes that brought Rover/Land Rover in-house in 1966, before taking a 16-month break to work with Mobil Oil. He returned in 1969, after MG and Jaguar joined the firm under the umbrella of the British Leyland Motor Corporation, and took on the role of corporate PR manager and chair for the BL advertising committee. He'd see Triumph through its final TR7 and TR8 days, as Jaguar Rover Triumph Inc. morphed into Jaguar Cars, Inc. Mike retired from Jaguar (then under Ford control) in 1991, but would come back on a part-time basis to manage the vast British car archives he helped preserve for Jaguar Land Rover, where he'd ultimately work with friend and fellow British Leyland (plus Volvo, Porsche, and more) alumnus Fred Hammond.
