



Dear Mr. Martin and fellow RMTC members,

I want to pass along my most sincere appreciation for what you did for me at my retirement party. It was an experience that exceeded my wildest expectations and your part of it made the day into an event of a lifetime for me. I will forever has a smile in my heart whenever I see the plaque your club gave me hanging on the wall at the shop. I am very sorry I did not get this message to you sooner, but in the week following, my life changed rather abruptly and unexpectedly.

Unfortunately, just a few days later things in my life became very much more difficult. When I was working alone at my old turn of the century warehouse in Denver, I sustained a significant setback. I experienced an accident where a heavy load of building materials (about 1000 pounds) collapsed on top of me and crushed me beneath. My legs hips and pelvis were squashed pretty good and my right arm was badly broken in multiple pieces just below the shoulder. Somehow I was able to extract myself from underneath the disaster I had created and was actually able to drive myself home (about 10 miles) with an effort that I still do not understand how I was able to accomplish. As the adrenaline wore off I could no longer walk and then it was off to the ER for x-rays, repairs, and further investigations. It was soon discovered that I had blood clots in my lungs which led to a long night in the ICU and thus eliminated the possibility of surgery to repair the broken arm. It is also not repairable with a cast so I must now wait it out to let the arm fix itself, a process that will take several months. The good news is that the recovery seems to be going fairly well with the pain involved having subsided significantly and i have been able to remove my self form the use of any painkillers. I am able to walk again which is quite a relief and now it's just a matter of waiting out the healing process. have now learned how to get it and out of bed without using my arms which is a bigger challenge that you might think until you've tried it. I am truly grateful because it could have been so much worse. It was not assured that this was a survivable incident, so I feel very blessed that things have gone as well as they have. We never know what is around the next bend in the road, do we?

Sadly, our planned trips to Maryland and Australia had to be postponed until next spring at best. It will be very difficult for us to wait that long, but we will be patient. I'll let you know how things progress. I could not be where I am today without tireless and unending support of my wife, Anne, and my daughter Becca who have put in an effort that has been beyond description for the last two months. I also attribute my remarkable improvement to be a result of a very palpable aura that has come from a hug number of phone calls, thoughts and prayers that have come to me from people on a ll corners of the world. This has been quite an experience, although not one I would care to repeat.



Collector Car Council of Colorado, Inc. Minutes of Meeting, 7 December 2022 (edited for space)

The meeting was held at the Forney Transportation Museum, 4303 Brighton Blvd., Denver CO

Guest Speakers: Mike and Jim McCutchen are seeking advice about selling vehicles from an estate left by their late father. The vehicles include a 1961 Ford station wagon and a 1964 International pickup truck. Both are not drivable and without titles. They will need information about getting titles for these vehicles. They were advised to check with the DMV and go through the process relying on a bill of sale and bonding when sold and to go to local swap meets to explore interest in the vehicles. Mike's phone number is 303-521-3821.

Legislative: Leo Boyle noted that the November election will result in new and predominately Democratic legislators on committees but key legislators we have worked with on the Transportation committees will be around. He reported that he will be meeting with the person most responsible for drafting legislative bills to seek clarification of SB19-054 which has been interpreted to mean all surplus military vehicles can only be licensed to be driven off-road like farm tractors. Leo also expects bills dealing with the metro area's ozone violations.

Concours d'Elegance: Discussion with Tom Scott regarding the June 4 2023 Concours in Littleton is continuing. The Concours is planning to feature evolution of the automobile with decades of vehicles grouped together. CCCC is urged to promote the show and provide 50 cars.


2023 RMMA (Jeffco) Airport Show: Dick Thompson reported that the August 5 th 2023 event may relocate to a different part of the airport which would afford parking on grass rather than concrete.

Colorado Parks Pass ("Keep Colorado Wild Pass"): The Parks Pass will go into effect on all registrations beginning January 1, 2023. There is an "Opt Out" provision rather than Opt In, meaning the fee can be declined and the registration reduced by \$29. The Pass if accepted is not transferable between vehicles. Only state parks are covered, not national parks such as RMNP. Vehicles without the pass can still enter state facilities by paying a day use fee.
